## **Natural Resource Management Update**

Continuing the momentum from recent Murray Darling Basin Plan submissions, which were presented to the Chief of Staff to the Minister for Water at the MLDRIN/NBAN meeting in May (see pictures below ), the NRM sub-committee has been engaged with the Office of Water (DSE) and Parks Victoria in the development of aspects of the draft State Water Strategy.

A new chapter titled "Traditional Owner and Aboriginal involvement in waterway management" has been drafted for inclusion in the Victorian Strategy for Healthy Rivers, Wetlands and Estuaries (VSHREW). The chapter and whole strategy will go out for public consultation in the coming months.

A case study on joint management for the 2012 Victorian Catchment Condition Report is also currently in development.

## **Aboriginal Heritage Act Update**

The review of the Aboriginal Heritage Act 2006 is now into its second stage and the Land Justice Group provided a further submission in response to the Government's Issues and Options Paper.

The Land Justice Group argued that Government could improve the ability of Traditional Owners to protect, preserve and manage Aboriginal cultural heritage for the benefit of all Victorians by:

- establishing a traditional-owner-controlled statutory authority •
- properly acknowledging traditional owners as the sole owners of cultural heritage .
- amending certain sections of the AHA to establish an open, transparent and deliberative RAP recognition • process
- ensuring that the process for protecting Aboriginal cultural heritage in Victoria is properly resourced
- supporting the cultural heritage system with effective enforcement and other policies that promote • Traditional Owner involvement in cultural heritage decisions.

The submission also stressed the need for Government to work in partnership with Traditional Owners on proposed changes to the AHA to alleviate the frustration experienced by Traditional Owner groups currently attempting to protect and preserve our cultural heritage, whilst at the same time improving the effectiveness of the system for everyone.
